2023 Giveback Cashback \$500 Cash Back Sweepstakes Official Rules

1.        **RULES.** Tyndall Federal Credit Union's 2023 Giveback Cashback \$500 Cash Back Sweepstakes is governed by these rules, terms, and conditions ("Rules"). Tyndall Federal Credit Union reserves the right to change these rules or cancel the Drawing at any time, at its sole discretion.

2.        **PROMOTION PERIOD.** 2023 Giveback Cashback \$500 Cash Back Sweepstakes is between June 1, 2023 at and July 31, 2023.

3.        **ELIGIBILITY.** \$500 Cash Back Sweepstakes is open to all persons, 19 years of age or older; entrants must be U.S. residents. Eligibility for membership with Tyndall Federal Credit Union is not required. Employees of Tyndall Federal Credit Union, Tyndall Elected or Appointed Officials, employees of Tyndall's advertising agencies, their immediate family members, and persons living in their household (whether related or not), are ineligible to participate in the Drawing. Void where prohibited or restricted by law.

4.        **ENTRY.** You may enter the Drawing in one of the following ways:

A. Make a bill payment through Tyndall's Bill Pay tool. Your account must be in good standing.

B. Alternate Entry Method: You may submit a manual entry by sending a postcard to:

Contest entry form must be completed in its entirety to be eligible for the Drawing. Manual entries must be received by July 31, 2023 to be entered into the Drawing. Manual entries (postcards only) may be mailed or submitted in person to a Tyndall representative no later than 4:30 PM (CST) on July 31, 2023 at the address above.

5.        **PRIZE & WINNER SELECTION.** Ten winners will be chosen at random. The prize for the drawing is cash back for your monthly bill payments to be paid. One prize valued at up to \$500.00. The first ten names drawn will win.

The Promotional Period ends on July 31, 2023. On August 4, 2023, Tyndall will conduct a random selection from all entries submitted during the Promotional Period and the winners will be announced, August 4, 2023, no later than 5:00 PM (CST).

Winners will be notified by email, phone, or mail of their selection, based upon information provided from our bill payment system or the manual entry form. Winners may also be announced on Tyndall's web site and Tyndall's Facebook page. In the event the randomly-drawn winning entry is found to be incomplete, a new Winner will be selected. This determination is made at the sole discretion of Tyndall Federal Credit Union.

6.        **Odds:** Actual odds of winning depend upon the total number of bill payments made.

7.        **Prize Restrictions:** Prizes are not transferable. Prize may not be exchanged for another prize or equivalent cash value. If any Winner does not want to accept the prize offered, he/she will sign a Prize Waiver Form and an alternate winner will be selected.

8. Tax Reporting: The Credit Union will report prize winnings as required by law. Winners are responsible for all applicable federal, state and local taxes, and fees associated with prize receipt, if any.

9. Additional Terms: By accepting a winning prize in the Drawing, the Winner agrees to be bound by the Drawing rules and releases Tyndall Federal Credit Union, its employees, agents, partners and business affiliates from any liability, claims for damages arising out of their participation in the contest and the acceptance, use, misuse, or possession of a prize. Winner authorizes Tyndall to use his/her full name, likeness, hometown, and/or state of residence, in addition to prize awarded, for advertising and publicity purposes in any media without compensation or consideration.
